Core Clinical Clerkships and Elective Rotations

Students start to undergo clinical clerkships at the end of the fourth year. **Student's name** outstandingly performed in all the clinical clerkship programs in Chiba University Hospital. The curriculum includes eight-week courses in Internal Medicine and General Surgery, four-week courses in Emergency Medicine, Cardiology, Pulmonary Medicine/Thoracic Surgery, Neurology/Neurosurgery, Pediatrics, Psychiatry, Obstetrics/Gynecology, and two-week courses in Family Medicine, Orthopedic Surgery, and Radiology. The grades are classified as, S: Excellent (100-90), A: Good (89-80), B: Fair (79-70), C: Minimum passing (69-60) (minimum passing mark is 60), and we do not provide school-wide comparison of our students. The grades of each course are shown in his school transcript in details.

Summary

In summary, **Student's name** performed in an excellent manner in both pre-clinical and clinical courses. The Chiba University School of Medicine was established in 1874 and has a prestigious history. Through a number of programs in our Graduate of School of Medicine, as well as through research and clinical programs abroad, we provide our undergraduate and graduate students with opportunities to experience highly beneficial education and training. Our graduates continue to play active and important roles in a wide variety of medical fields.

Special characteristics of the medical school's educational program:

Our school encourages students to engage in international activities and participate in extracurricular volunteer work, which allows them to become physicians with a broad perspective of life. We also stress experience in basic medical sciences, and all third-year medical students are assigned to a basic science laboratory for one year to gain basic medical research skills.

Description of the evaluation system used at the medical school:

We have 2-semester system. Students are given writing assignments and assesses each semester and attendance is taken at each class meeting. At the end of a semester, students are given final tests. During clerkships, they collaborate with staff doctors in our wards and clinics. Attending physicians evaluate them based on case presentations, history taking, physical examinations, clinical reasoning, interpersonal skills, and attitude for self-directed learning. Also, over the three months immediately prior to graduation, they take a series of cumulative tests, and passing scores on all of these tests are required for program completion.
